**Feedback to Korea on the level of implementation of IOTC Conservation and Management Measures identified by the CoC14 in 2017.**

**Feedback:** With regards to the level of compliance by Korea to the decisions of the Commission, the Compliance Committee noted certain issues that required attention. These concerns were communicated to Korea by the Chair of the Commission in a letter dated 26<sup>th</sup> May, 2017.

• Has not reported size frequency for surface fishery to IOTC Standard (Less than one fish per metric ton of catch per species), as required by Resolution 15/02.
• Has not reported size frequency (Provisional) for longline fishery to IOTC Standard (Less than one fish per metric ton of catch per species), as required by Resolution 15/02.
• Has not reported size frequency (Final) for longline fishery to IOTC Standard (Less than one fish per metric ton of catch per species), as required by Resolution 15/02.
• Has not fully implemented the requirement of 5% mandatory at sea for vessels > 24 m, as required by resolution 11/04
• Has not provided observer reports, as required by Resolution 11/04
• Has not provided the BET annual report to IOTC Standard, as required by Resolution 01/06

**Response:** The response to the letter of the Chair of the Commission was provided by Korea on 19 April 2018.
